- That M. M. SCHOOL SOCIETY is a registered Society/Trust under the Society Registration Act 1860.
- That the M. M. SCHOOL SOCIETY is of Non-Proprietary Character.
- That the school is being run as a community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
- 4. That no part of income from the Institution is being and will be diverted to any individual in the Trust/Society/Company/School Management Committee or to any other person/entity. The saving, if any, after meeting the recurring and non-recurring expenditure and contributions to developmental, Depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.
- That school has not paid any charges towards using name, motto, logo to any other institution, organization or body.
- That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
- 7. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the Delhi School Education Act & Rules 1973, affiliation & examination byelaws, legitimate directions issued from time to time and the law of the land.
- That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.
- That the school will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued by the concerned municipal or state authorities.
- 10. That the school will ensure that all required infrastructure is available with the school before starting classes.
- 11. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bye-laws are available with the school before starting classes.

That in case affiliation has been with certain conditions, the school will not start CBSE pattern classes without submitting a certificate/affidavit to the effect that the school has complied with all the conditions imposed by CBSE and the postaffiliation conditions contained in affiliation byelaws along with general rules.
