Dear Parents.

In purview of the safety of our children and adopting safety measures in compliance with the government guidelines, please note that the following checkpoints are must for all parents whose children commute by private vans-

- Students must be dropped to the school only 10 minutes before school timings i.e., 7:45 a.m. Entry in the school will not be allowed prior to 7:45 a.m.
- 2. Private van must be registered with the State Transport Authority as a school cab.
- 3. Private van driver's verification must be done from Delhi Police and parents must have a copy of police clearance certificate.
- 4. Private van driver must have a valid license and minimum 5 years of experience in driving such categories of vehicles. Also, he must not have any record of previous traffic offences.
- 5. There must be a lady attendant / mother volunteer always present in the van to ensure safe travel of the children and render adequate assistance for safe embarking and disembarking of children.
- 6. Vehicle should not carry children in excess to its permitted seating capacity.
- 7. There must be a first aid box and drinking water available in the vehicle strictly.
- 8. The seat belts, wherever applicable must be fastened properly.
- 9. Van driver must strictly follow the guidelines issued by the Hon'ble Supreme Court of India, Delhi Police and Delhi Motor Vehicle Act, 1995.

In order to have a record with the school, the parents are advised to submit the details pertaining to the private vans in the prescribed performa given below. The Performa is to be submitted by 09.08.2022 in the school office under acknowledgment.
